FOOTNOTES

- [1] A qualified voter is anyone with ownership interest in property within the boundaries of Brannan-Andrus Levee Maintenance District (Andrus Island, Brannan Island, or Lower Andrus Island). In the event of multiple owners, parcel may only be represented by one person.
- [2] The term of office for a Director of Brannan-Andrus Levee Maintenance is four years, and extends until the Director’s successor takes office. (Water Code (“WC”) §50602). A newly-elected director will take office (and the term of an incumbent Director will expire) at noon on the first Friday in December, following the District election and after taking and filing an official oath of office with the Sacramento County Clerk. (Elections Code (“EC”) §1304)
